

# Terms and Conditions

## Terms and Conditions

1. The Promoter is The Promoter is Lendlease Property Management (Australia) Pty Ltd of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is (07) 4944 7111.
1. Only residents of Australia aged 13 years of age or older (**Participant**) are eligible for the Competition. Participants under 18 years of age must obtain the prior permission of a parent or guardian over the age of 18 years to enter the Competition, evidenced by the parent or guardian signing the entry form.
2. The following person(s) are ineligible to enter the Competition:
  - (a) employees of:
    - (i) any retailer within Caneland Central
    - (ii) the Promoter; and
    - (iii) the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
  - (b) members of the Immediate Families of the employees referred to at paragraph 3(a).  
**Immediate family** means any of: a spouse or domestic partner, ex-spouse or ex-domestic partner, de-facto spouse or ex-de-facto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.
3. The Competition commences at 9am on Friday 28<sup>th</sup> of February 2020 and finishes at 5.30pm on Friday 27<sup>th</sup> of March 2020 (**Competition Period**). The Promoter may extend the Completion Period at its sole discretion (**Extended Competition Period**). References in these terms and conditions to the Competition Period include any Extended Competition Period, where applicable.
4. The prizes are one \$250 Caneland Central Gift Cards, given away each week for the four-week period, totaling \$1000. The value of each prize is \$250.
5. To enter, the Participant must take a photo in front of the photo wall located on Level One (ex-Harris Scarfe tenancy windows) during the Competition Period. They will need to upload the photo on Facebook using the hashtag #PunlandCentral, and set the post to public for us to see their entry.
6. For the Participant to be eligible to compete in the Competition, the Participant must enter the Competition:
  - (a) within the Competition Period;
  - (b) in the strict manner specified on the entry form for the Competition; and
  - (c) by the method specified on the entry form for the Competition.

14. The judge's decision is final and no correspondence will be entered into.
15. By entering into the Competition the Participant (or its parent and guardian) is/are deemed to have accepted these terms and conditions.
16. The Promoter reserves the right to request winners to provide proof of age and identity and eligibility to participate in the Competition. In the event that a winner cannot provide suitable proof, the winner will forfeit the Prize in whole and no substitute will be offered.

2. Prizes must be collected from the Customer Service Desk at Caneland Central by Monday 1 June 2020. If the winner is under the age of 18 years, the winner's parent or guardian must accompany the winner in order to collect the Prize and the Prize will be awarded to the winner's parent or guardian.

Any condition or warranty which would be implied by law into these terms and conditions is excluded.

As a condition of accepting a Prize, the winner (or the winner's parent or guardian), and any other person(s) sharing the Prize with the winner, may be required to sign legal documentation as and in the form required by the Promoter including but not limited to a further agreement to exclude liability of the Promoter for certain loss, damage or injury arising from the use or participation in a Prize to the extent the Prize is or includes a recreational service or activity.

The Promoter may conduct such further judging of entries if, despite using all reasonable efforts, the original winner cannot be contacted, at the same place as the original judging as is necessary at 5pm on each Tuesday during the competition period, following the winner selection (at 9am on each Friday during the competition period) in order to distribute any unclaimed Prize.
20. All entries become the property of the Promoter.
21. The Promoter may cancel the competition and not award the Prize(s) where circumstances beyond the Promoter's reasonable control prevent the Promoter from providing the Prize(s). Should the Promoter cancel the Competition the Promoter will:
  - (a) advertise that the Competition has been cancelled by placing a notice on the Competition's website at on [www.canelandcentral.com.au](http://www.canelandcentral.com.au);
  - (b) promptly destroy all entries received; and
  - (c) not use the personal information that any Participant has provided on the entry form.

The Promoter reserves the right to substitute any Prize with a prize of equal or greater value (including where the Prize is unavailable) for whatever reason, subject to approval of the gaming authorities in each State and Territory where required.
