

## CANELAND CENTRAL GIFT WITH PURCHASE TERMS & CONDITIONS (WITH PRIVACY STATEMENT)

1. Information on how to enter forms part of these terms and conditions.
2. Entry is only open to residents of Australia aged 18 years and over. Employees of the Promoter and their immediate families and retailers within Caneland Central and the retailers' employees and their immediate families are ineligible to enter.
3. Promotion commences and free gifts are available from 9:00am Thursday 3<sup>rd</sup> December 2015 until 5:30pm Wednesday 9<sup>th</sup> December 2015 or when a total of 200 free gifts have been claimed, whichever is earlier. There will be a registry of all free gifts claimed at the Customer Service Desk. Once 200 free gifts have been claimed the promotion will cease.
4. For a customer to receive a free Lorna Jane 2016 Diary valued at \$39.99 ("free gift") at Caneland Central Customer Service Desk, on the ground floor opposite Wallace Bishop, he or she is required to provide proof of purchase for a spend of \$150 or more in one transaction in the purchase of Caneland Central Gift Cards from the Customer Service Desk (\$150 or more gift card purchase can be made up of multiple gift cards, as long as they are in the same transaction, e.g. 2x \$75, 5 x \$30 gift cards). Subject to Your Consumer Rights, the Promoter is not liable for any loss or damage however caused (including by negligence), suffered or incurred in connection with the Promotion or the free gift. Any condition or warranty which would be implied by law into these terms and conditions is excluded.
11. The promotion is in no way sponsored, endorsed, administered or associated with Facebook.
12. As detailed in the privacy statement which accompanies these term and conditions, customer names will be entered into a register of customers who have received the free gift and the customer names will be used to ensure compliance with the terms and conditions of this Promotion.
13. The Promoter may cancel the Promotion and not distribute the free gifts where circumstances beyond the Promoter's reasonable control prevent the Promoter from providing the free gift. Should the Promoter cancel the Promotion the Promoter will:
  - (i) advertise that the Promotion has been cancelled by placing a notice at the customer service desk in the shopping centre; and
  - (ii) promptly destroy The register identifying customers who have received the free gift; and

- (iii) Not use the personal information included on the register identifying customers who have received the free gift.
