## CANELAND CENTRAL GIFT WITH PURCHASE TERMS & CONDITIONS (WITH PRIVACY STATEMENT)

1. Information on how to enter forms part of these terms and conditions.
2. Entry is only open to residents of Australia aged 18 years and over. Employees of the Promoter and their immediate families and retailers within Caneland Central and the retailers' employees and their immediate families are ineligible to enter.
3. Promotion commences and free gift cards are available from 9:00am Monday 20<sup>th</sup> July 2015 until 4:00pm Saturday 25<sup>th</sup> July 2015 or when a total of 1,250 free gift cards have been claimed, whichever is earlier. There will be a registry of all free gift cards claimed at the Customer Service Desk. Once 1,250 free gift cards have been claimed the promotion will cease.
4. For a customer to receive a free \$20 Caneland Central Gift Card at Caneland Central Customer Service Desk, on the ground floor opposite Wallace Bishop, he or she is required to provide proof of purchase for a spend of \$100 or more in a single transaction from a participating Caneland Central retailer. The customer will be required to provide their name, phone number and email address to claim their gift.
5. The receipt proving purchase of \$100 or more in one transaction from a Caneland Central retailer must be dated from and including Monday 20<sup>th</sup> July 2015 to Saturday 25<sup>th</sup> July 2015. Receipts dated outside of these dates will not be accepted.

A customer can receive a maximum of 10 (ten) free \$20 gift cards per person per day, if multiples of \$100 are purchased, e.g. spend \$300 in a Caneland Central retailer, and receive three (3) free \$20 gift cards; spend \$1,000 or more in a Caneland Central retailer, and receive ten (10) free \$20 gift cards. Once a receipt has been presented, no balance amount or part thereof can be used for future redemptions.
7. Participating retailers for this promotion include all Caneland Central retailers. Woolworths and Coles are excluded from the promotion and are not participating retailers.
8. Bill payments such as the payment of credit card bills, bank transactions, bank fees and charges and service bills (such as gas, electricity, rates and phone bills) are not accepted as part of the Promotion.
